 Only Persons with Benchmark Disabilities (PwBD) from category Low Vision', which has been identified as suitable, will be considered for the purpose of reservation, in view of Haryana Government Gazette Notification dated 25.10.2021.

 Persons with Benchmark Disabilities (PwBD) of other categories can also apply even if the post is not reserved for them but has been identified as suitable. However, such candidates will be considered for selection to such post by general standard of merit and without any relaxed standards. Those candidates cannot avail age limit relaxation as is given to PwBD category candidates, for whom posts have been reserved.

 Candidates seeking reservation under PwBD category would be eligible for reservation in services/posts who suffer from not less than 40 per cent of the relevant disability. Department, any Government Corporation/Board/Institution are required to apply through proper channel.
