**[For recruitment to the posts of Daily Rated Worker (DRW)]**

Online applications are invited in prescribed form available in the official website of the High Court of Tripura (<http://thc.nic.in>) from persons who are not below 18 years of age and not more than 40 years of age (45 years in case of candidate belonging to Scheduled Castes & Scheduled Tribes) as on **02.04.2025** for filling up **10 (ten)** vacant posts of Daily Rated Worker (DRW) in the establishment of the High Court of Tripura, Agartala:

**Out of 10 posts, 04 posts are meant for UR category, 04 posts are reserved for Scheduled Tribe and 02 posts are reserved for Scheduled Caste.**

If no suitable candidate of reserved categories is found available as aforesaid, the posts may be filled up by the candidates other than those of the Scheduled Tribes and Scheduled Castes as per Rules.

The number of posts may increase or decrease. A panel of select list will be prepared based on the merit of Written Examination and Viva Voce and it will remain valid for 1(one) year from the date of publication of the result.

DRW engaged will have to work as Orderly, Washerman, Mali, Cleaning Assistant etc. and candidates having experience in those fields will be given preference.

A candidate must be a citizen of India as defined in Articles 5 & 6 of the Constitution of India and **must be Class-VIII passed or equivalent.**

ST/SC candidates of other States should apply as unreserved category candidate alongwith Application fees prescribed for such candidates.

The application fee for **UR category applicant is Rs.300/- (Rupees three hundred only) and that of reserved category (SC/ST) applicant is Rs.150/- (Rupees one hundred & fifty only)**. Fees once deposited will not be refunded or adjusted for any other recruitment in future. Candidates are to deposit fees by using Credit Card (Visa/Master/Rupay), Net Banking, Debit Card (Visa/Master/Rupay), Wallets & Cash Cards & UPI only. No other mode of payment will be accepted. Bank charge may apply.

The candidate shall have to appear in the Written Test of 75 marks of MCQ/Objective Type Questions covering the subjects: General Knowledge, Current affairs & General English etc. followed by Viva Voce of 25 marks. Only those candidates who qualify in the Written Test shall be called for Viva Voce. Ratio of candidates short listed through Written Test shall be 1:6 i.e. for 01 (one) advertised post 06 candidates will be short listed for oral interview.

Disqualification for appointment– No person shall be eligible for appointment to the service-

- (a) Unless he is a citizen of India; or
- (b) If he has been dismissed from service by the Government, Central Government, High Court, statutory or Local Authority; or
- (c) If he has been convicted of an offence involving moral turpitude; or
- (d) If he has more than one spouses living; or
- (e) If he directly or indirectly tries to influence the recruiting authority by any means.

### **IMPORTANT NOTES**

- i) Online Application:
  - a) Candidates have to submit application through Online Application Portal only. The High Court will not entertain any hard copy application. Before submission of online application, the candidates are to read the instructions carefully in the 'How to Apply' segment of the Online Application Portal.
  - b) Online Application Portal will be available on the High Court's Website (<https://thc.nic.in>) from **03.03.2025 (from 12.00 Noon) to 02.04.2025 (upto 05:00 P.M.)**. To apply the candidates have to click on the 'Recruitment' tab in the Home page of the High Court's website.

- c) Candidates should avoid submitting multiple applications. However, due to any unavoidable circumstances, if any candidate submits multiple applications then he/she must ensure that the application with latest Registration Number is complete in all respect.
- d) In case of multiple applications, the application with the latest Registration Number shall only be entertained by the High Court and Fee paid against one Registration Number shall not be adjusted against any other Registration Number.
- ii) Candidates who are eligible for Written Test will be asked for scrutiny of original marks-sheets/certificates/documents before appearing in the Written Test.
- iii) Candidates shall have to bear their own expenses for appearing in the Selection test.
